Manager Sibole explained that the steps being taken will hopefully deter or slow down future robberies. It is very difficult to make the areas completely secure, but they are doing their best. Foreman Bruce Torola has been closely monitoring the camera security system at Sunnyslope making sure it is working as it should and working on fortifying everything he can inside as well.
